Vice Chancellor Stewart turned the floor over to Marketing for an update on Madison's Mascot.

Vice Chancellor Stewart briefly touched on the launch of the MVP program. Grote, LG&E, and Nucor have all partnered with Ivy Tech for 2024.

Chairperson Dozier turned the floor over to Amber Finnegan for a Correctional Education update. WHEREAS, development of the criteria and guidelines for the Ivy Tech statewide budget has been completed by the College Officers and State Board of Trustees following passage of the budget by the General Assembly, and

WHEREAS, operating revenues for the Madison Campus have been estimated to be \$3,015,087 in student fees and \$12,910,918 in miscellaneous revenues and Indiana Department of Correction contracts for the 2024-25 fiscal year, and

WHEREAS, this revenue combined with a state appropriation, result in a total operating expenditure budget of \$23,932,832 with an initial carry forward budget of \$4,076,183 for the 2024-25 fiscal year, and

WHEREAS, adjustments to the budget will occur during the course of the fiscal year and provisions have been made to adjust the expenditure budget to be commensurate with changes in the revenue budget,

NOW THEREFORE BE IT RESOLVED, that the Madison Campus Board of Trustees do hereby approve a total operating expenditure budget of \$19,856,649 for the 2024-25 fiscal year.

Report to Campus Board of Trustees Academic Affairs August 2024

Introduction to New Vice Chancellor of Academic Affairs

Kay Stokes, the new Madison Campus VCAA, began work on July 1. Kay comes to us from Hanover College, where she worked for 27 years in a variety of roles. She created and directed Hanover's academic support programs, including its one-stop tutoring center, Accessibility Services program, and its first-year success seminar. Kay also taught journalism, creative writing, and literature through the English Department. For the last six years, Kay worked as Special Assistant to the President, overseeing new program development, strategic planning, community outreach, and special initiatives, including the 1+2+1 Nursing partnership and the Veterinary Teaching Center with Ivy Tech.

Kay is a Florida native who holds a B.A. in English Literature from the University of Florida. She had an early career as a journalist, covering state and local government for New York Times-owned newspapers in Florida, before returning to school for an M.A. in English Literature and M.F.A. in Creative Writing from McNeese State University in Lake Charles, Louisiana. She will begin a doctoral degree in Higher Education Leadership in January through Maryville University in St. Louis.

Kay has a long-standing passion for adult education and for improving educational attainment rates for southern Indiana residents. Her goals include the successful launching of the Nursing and Veterinary partnership programs and increasing focus on teaching and learning on the Madison campus. She has received a warm welcome and is very happy to be at Ivy Tech-Madison.

Spring Graduation

More than 400 students earned degrees and certificates at Ivy Tech-Madison this spring. The graduation ceremony was held on Saturday, May 11th at the Belterra Casino Resort. The event was attended by Ivy Tech President Sue Ellspermann, Campus Board of Trustees President Carol Dozier, faculty, staff, 150 graduates, and many excited family members.

New Academic Program Updates

1+2+1 Nursing Partnership

Forty new Nursing students will begin the Madison ASN program on August 18th, including 11 Hanover College sophomores participating in the new 1+2+1 Nursing program. HC students will attend professional/clinical courses on the Ivy Tech- Madison campus for the next two years while also working toward bachelor's degree requirements at Hanover. In Spring 2026, they will graduate from Ivy Tech with an ASN in Nursing and take their NCLEX exam. Their senior year at Hanover will be spent taking BSN courses for graduation in Spring 2027 with a Bachelor of Science in Nursing.

Initial projections for the 1+2+1 program are on track. Program founders anticipated 10 students in its first cohort and 20 in its second. The incoming 1+2+1 students hit that mark, and Hanover now has at least 20 incoming first-year students enrolled in Nursing pre-requisite courses this Fall.

Veterinary Nursing AAS and Veterinary Assistant CT

Veterinary program director Dr. Melissa Newcomb is scheduled to begin work on August 8th. Newcomb brings over 20 years of veterinary experience, as well as over 17 years of experience in education. Newcomb received her Doctor of Veterinary Medicine from Purdue University in 1996. She spent 12 years as an Associate Veterinarian at Hillview Veterinary Clinic in Franklin, Indiana, focusing on high-quality care in medical, surgical, and emergency



cases. Newcomb then made a shift into education, receiving her Master of Arts of Teaching in 2017 from the University of Indianapolis. She then taught Biology, Advanced Animal Science, Science, and Math courses for junior/senior high school grade levels.

The first Veterinary advisory committee meeting was held April 22nd. Attendees included local veterinarians, Dr. Robin Waltz and Dr. Joy Barron, Dr. Newcomb, and Dr. Tina Tran, founding dean of Hanover's Doctor of Veterinary Medicine program.

The Veterinary Nursing AAS and Veterinary Assistant CT are on track for approval by the Commission for Higher Education. The programs are on the consent agenda for the CHE meeting in the last week of July. Once approval is received from CHE, the campus will then begin the program approval process with the Higher Learning Commission, Ivy Tech's systemwide accreditor. Based on these successful benchmarks, the programs are on track to start in 2025.




Trend Data for Fall 2024

Marketing Update:

Ivy Tech Madison partners with Williams Randall, a full-service ad agency. Williams Randall specializes in providing recurring reports centered around analytics, measurement, and tracking. These reports offer a comprehensive breakdown of the effectiveness of various marketing strategies. These reports not only highlight what strategies proved effective, but also dive into areas that could have been more impactful and explain the reasons behind their performance.

Ivy Tech Madison completed the 2023-2024 campaign year with an estimated 2 million impressions from YouTube, Snapchat, Google, Facebook, and Instagram and an estimated 4 million impressions from geofencing and billboards. Madison campus received 682 application completions and 267 request for information form completions. Snapchat was a top performer bringing in 159 application completions. In partnership with Williams Randall, Madison campus will continue to optimize our marketing efforts each year. Madison campus will sign a new contract with Williams Randall for the 2024-2025 year.

K14 Update:

The K-14 team has had a great summer of growth and collaboration.

On June 12th, members of our campus celebrated Mary Schmaltz, our 2024 President's Award for Excellence in Dual Credit Instruction, at the statewide awards ceremony. Mary teaches dual credit CNA and Dementia Care at Southeastern Career Center, and prior to teaching spent more than 20 years in hospital nursing and management. In nominations sent by her students, they shared she does an outstanding job of blending classwork with practical lab experiences, letting students not only learn about the skills they need, but also creating environments and situations that let them practice those skills in a realistic manner. We are proud to recognize Mary for her dedication to students and the positive impact she has on their lives!

Thanks to the ongoing success of state-funded Crossing the Finish Line and the College's Free Summer initiative, we welcomed a record 252 high school students this summer - a 41% increase from last summer.

Student success is always a primary focus for our team, and this summer we placed special emphasis on increasing support for our virtual Indiana Digital Learning School students. Through weekly communication, targeted assistance for struggling students, and helpful resources, we have seen an increase in successful course completion. We plan to continue implementing these strategies to support all of our high school students moving forward.

We were also pleased to partner with other departments on campus to support their youth-focused summer initiatives, including the Healthcare Academy and CareerLink's Camp Career Quest. These programs provided valuable experiences for students interested in exploring health careers and other career opportunities within our community. We appreciate our ongoing partnership with CareerLink and look forward to collaborating further this fall as we implement new strategies to assist our pathway students with career exploration and readiness.

We are ready for the fall term and excited to welcome our high school students back to campus on August 7th for their preterm IVYT courses!





Ivy Tech Correctional Education

Executive Summary from the 2023-2024 Annual Report

Ivy Tech has completed its third year with the IDOC Correctional Education contract. As last year focused on building a solid foundation for success, this year Ivy Tech made significant strides in enhancing its academic programming and instruction through a series of targeted strategies. The goal to expand the tutoring program in partnership with IDOC, was successfully achieved, resulting in improved recruitment and training methods. Continuous Quality Improvement (CQI) processes, Arbinger's *Outward Performance* program, and Professional Learning Communities were implemented along with state-wide consistency on Adult Learning Plans. New training programs were introduced for instructors significantly boosting teaching skills and performance metrics. Although enhancing technology use in facilities has faced some challenges, ongoing efforts and collaborations promise continuous improvements.

Challenges this year have included prison shutdowns, switching HSE testing from HiSET to GED, the referral process through Delta, and a new Ivy Tech Workday system. Sites have continued to problem-solve barriers to strive toward meeting metric outcomes. Despite enrollments decreasing slightly, completions managed to increase slightly. Below is a summary of key metrics for Correctional Education:

IET Enrollments and Completions

This program year we focused heavily on our IET programs, ways to increase enrollments and completions, minimize downtime in between classes, and have the programs complete by the end of the academic year. Our efforts were rewarded with a 40% increase in enrollments, and a 125% increase in completions. This program year members of the Correctional Education State team partnered with IDOC Educational Leadership to participate in a year-long national IET Design Camp program. Indiana was one of 8 states to participate in this program.

The vocational classes continued with a strong performance in both enrollments and completions this program year. Starting July 1, 2023, all vocational students were entered into Ivy Tech's student data system, Banner. This integration brought multiple benefits for students and enabled our staff to track enrollments and completions in real-time. Despite significant challenges, such as Westville being unable to run vocational classes for a significant part of the year and vocational instructor vacancies at other sites, along with technology challenges, our enrollments and completions showed overall improvement, exceeding our enrollment goal, but falling just short of our completion goal.

2023-2024 Goals and Objectives Outcome Summary:

Goal #1: Teaching and Learning: Deliver high quality academic programming and instruction.

Achieved:

- The tutoring program by partnering with IDOC now offers improved pay and incentives to attract more tutors, including incarcerated individuals by reviewing recruitment strategies each quarter.
- A new Tutor Training and Process manual was developed and Ivy Tech staff now have a training program, documents, and SOPs to use with their tutors.

- Numerous on-line professional development opportunities and conferences have been offered to correctional education throughout the year in addition to IEP training and Professional Learning Communities training.
- A new GED Pacing Guide was developed along with resources for the transition of the GED test.
- A teacher mentoring program was developed and implemented, and a standardized ALP was developed with training.
- Ivy Tech has provided technology tools to support instructors in delivering effective instruction that are centrally stored and accessible to teachers, along with providing a platform to enhance communication such as vocational roundtable meetings. All sites now have cameras and speakers for their computers to enhance networking, meeting attendance and professional development, along with Study Buddies and TVs for classroom instruction.

This year's Table 4 exceeded our goal of 75% to reinforce the strategies used to increase teacher performance have been impactful.

Goal #2: Workforce and Careers: Identify areas of improvement and established partnerships with internal and external stakeholders to improve workforce connections.

Achieved:

- Ivy Tech continues to meet with HIRE to collaborate on re-entry workforce success strategies.
- A new strategic plan booklet was developed and has been distributed to sites. Sites continue to provide Ivy Tech marketing materials to students. The State team did a presentation on its programs to over 350 IDOC case managers in April 2024.
- IDOC and Ivy Tech continue to meet on a regular basis to review vocational programs.

Goal #3: Increase student engagement.

Achieved:

- Ivy Tech has enhanced the use of the incentive matrix to more intentionally recognize students' progress and continues to brand participants as Ivy Tech students, emphasizing the benefits they will gain upon release, and developing strategies to engage and motivate them effectively.
- Last year, the separation rate was 15% this year it is 10% which indicates a 5% reduction in student separation.

Goal #4: ITCC will assist sites in maximizing operational effectiveness

Achieved:

- Ivy Tech offered foundational leadership skills training to enhance the leadership capabilities quarterly to CE Site Managers and the State Team.
- Regional managers, Mike Thombleson and John Rajanayakam provided team activities and meetings to their sites throughout the year.
- The State team has continued to meet with larger sites -IYC, WCC, MCF, NCCF, HTCF and ISF on a quarterly basis to discuss administrative challenges/responsibilities.
- All Correctional Education staff were provided Arbinger's Outward Performance training and the feedback from the training was favorable. The tools utilized in this training are available to all staff and sustaining concepts are being developed at the state and site level.
- CQI processes were developed and rolled out this year in the 2nd quarter. These
 measures have contributed to our increase in metrics.

Goal #5: Ivy Tech will partner with IDOC to enhance the use of technology in Correctional Education.

Partially achieved:

- Ivy Tech in partnership with IDOC has provided all instructors with computers and internet connectivity.
- Ivy Tech has started to utilize student tablets for education. Numerous videos and content are in the process of being added to CypherWorxs.
- Ivy Tech and IDOC were not able to update Business Tech computer labs, incorporate online/offline CTE certification testing, or online/offline high school equivalency testing.
 Ivy Tech and IDOC will continue to partner with IT to enhance technology with in the education program.

Human Resources

- Our annual evaluation and merit process is now complete.
- We are currently hiring for our next Executive Director of CareerLink as well as our next Career Coach.
- IDOC staffing remains solid with the main hiring focus on finding our next Site Manager for Westville Correctional.

Facilities

- Our Nursing expansion and renovation project completed early and on budget.
- Preparation is now underway for hosting SBOT in early October.

CareerLink

- 1st annual Career Camp was a success this summer.
- Partnering with the K14 team for additional career exploration opportunities.
 Building Your Future Fridays" will begin next month
- Skills trainings continue to be impactful with current trainings for the Community Foundation of Switzerland County, Arvin Sango, IDOC (HVAC training). We have trainings in the works with Nucor, MPP, Belterra and Belterra Park leadership.
