WHEREAS, Ivy Tech Community College is committed to ensuring a safe campus and work environment for all students and employees, and

WHEREAS, the Indiana General Assembly recently passed HEA 1430 requiring the Division of Mental Health and Addiction Planning of the FSSA to develop a statewide program of suicide prevention, and

WHEREAS, the legislation requires the State Board of Trustees to adopt a policy to increase awareness of suicide prevention resources available to students and staff, and

WHEREAS, President Ellspermann formed a working group to develop a suicide prevention policy for the College to support the state's program, and

WHEREAS, the College's working group was made up of the following:
